The Lexington City Council met in a Regular Meeting on Monday, April 8, 2024, at 6:00 p.m., at City Hall, 604 Wheatley, Lexington, Texas.

Present was Mayor Allen Retzlaff, Councilpersons David Mason, Dana Matson, Dale Phelps, Bobby Wesner and Anthony Retzlaff.

Mayor Retzlaff brought the Regular Meeting to order and welcomed the guests.

3. A Public discussion was held to review the design and acquisition plans for the new GLO Flood and Drainage Project.

4. David Mason made the motion to approve the Regular Meeting minutes of March 11, 2024. Dale Phelps seconded the motion. Vote 5 for.

5. David Mason made the motion to approve paying the bills for the month of March, 2024. Bobby Wesner seconded the motion. Vote 5 for.

6. Dana Matson made the motion to not make any changes to the noise ordinance. Anthony Retzlaff seconded the motion. Vote 5 for.
